John F. Kennedy International School

Saanen, Switzerland

A. Registration Fee & Guarantee Deposit

- A non-refundable one-time registration fee of CHF 2'000 per student covers administrative processing and entrance examinations. In the event of an unsuccessful application, it may be applied towards a reapplication the following year.
- Upon acceptance, a guarantee deposit of CHF 5'000 is required to secure the student's place. This deposit covers any outstanding supplementary expenses and the balance will be reimbursed at the end of the term following the student's departure from the school, provided all accounts are settled.
- No further fees are required as part of the application procedure.

B. Annual Fees (Boarding + Tuition)

Annual Fees are payable in full by **30 June 2026**. (or 7 days for invoices issued after this date)

Winter term fees are due **14 days** after the invoice has been issued.

By enrolling, parents commit to the full academic year's fees. Boarding fees must be paid in full prior to enrolment confirmation (required for entry visa procedures for some nationalities).

C. What School Fees Cover

The annual boarding fee includes the following:

- All official academic classes
- Classroom textbooks & stationary supplies
- Use of facilities: laboratories, library, art rooms and internet access
- Compulsory excursions, events and cultural trips (autumn overnights & spring trips)
- Ski lessons during the Winter Term
- Season ski pass
- PE and sports classes in the curriculum, including swimming
- Full board and accommodation (all meals)
- Boarding activities
- 2 Excursions during the long weekend (February & May)
- Sundries
- Health insurance premium
- Provision of all bed linen
- Laundry service (dry-cleaning excluded)

D. Supplementary & Extra Charges

The following Supplementary and extra charges are invoiced at the end of each term, and are payable within 30 days of issue. Parents wishing to contest an invoice must do so in writing 30 days of issue.

Uniform

JFK school uniform is mandatory every day. It includes:

- Autumn/Spring (Summer Uniform): JFK soft shell, navy blue cargo pants, white polo shirt, navy blue v-neck jumper, navy blue Bermuda shorts, JFK backpack.
- Winter (Winter Uniform): JFK red ski jacket, soft shell, black ski pants, white turtleneck, JFK black or red hat, neck-warmer and JFK backpack.
- Sports clothing: JFK sports bag, waterproof rain jacket and pants, swimming equipment, hiking shoes, trainers, JFK white sport T-shirt, sport shorts, track pants and top, JFK cap.

Extras — Billed Termly

- Extra-curricular activities and private lessons in any academic subject
- Fees for external examinations
- Academic trip in Autumn and Graduation trip (Year 9 only)
- Telecommunications: postal and telephone (SIM card) expenses, courier services and customs taxes for parcels received
- Transport organised on parental or student request (with parental authorisation): flights, train tickets, taxis
- Swiss entry visa and resident permit costs
- Pocket money distributed to students once per week

E. Re-Enrolment Procedures

- Current students are automatically re-enrolled for the following academic year, unless requested otherwise and if all financial conditions have been met.
- Parents wishing to withdraw their child must inform the school's administration in writing no later than last day of March each year.

F. Contractual Financial Conditions

- If a student is suspended, expelled, or withdrawn by the parents during the course of a term, all outstanding fees remain payable.
- If a student is withdrawn by mutual agreement between the parents and JFK, the fees for the current term remain payable.
- Parents are liable for any damage caused to the school or its property by their child.
- Any valuable objects (watches, jewelry etc.) are brought to school at student's own risk. JFK does not provide insurance cover against theft or loss of personal property.

G. Health & Accident Insurance

All boarding students will be covered by the school's collective medical insurance policy covering sickness, accidents, hospital costs and medical treatment.

JFK manages all administration relating to boarding student medical insurance. Medical and dental treatments not covered by the insurance will be debited from the student's account.

- Prior to arrival, parents must submit a health questionnaire completed by their family doctor.
- Parents with resident status in Switzerland must insure their children under the LAMal sickness and accident insurance scheme and provide JFK with the necessary information.
- The policy provides private cover in all Swiss hospitals. During visits abroad (trips, holidays), treatment is covered up to the equivalent cost of treatment in Switzerland. Orthodontic treatment is covered under certain conditions. Dental fees are not covered except in cases of accident. The insurance policy is effective from 1 September to 31 August. Full Terms & Conditions are available from the school administrator.

I. Late Payment

Invoices are payable within 30 days of the date of issue.

- A late interest charge of 5% per annum will be applied to any outstanding balance.

J. Use of Photos & Personal Data

As part of its communication policy, JFK may use photos and videos taken during school activities, celebrations, special events and sporting competitions in its publications, including its website and documents sent to parents. In accordance with Swiss droit à l'image legislation, parents are deemed to consent to this by signing the present document.

Parents who **do not agree** should inform the school administrator at info@jfk.ch. Parents will be able to modify their consent for video and audio use in the Veracross Parent Portal.

Data collected is required for logistical reasons associated with the student's participation in sports events and school trips. Such data may be shared with partner schools and sports organisations of which JFK is a member, solely for the purposes of the relevant event. Partner organisations are requested to securely destroy data upon completion of each event. Only data necessary for each specific event will be collected.

K. Contractual Agreement & Governing Law

- By enrolling or re-enrolling their child, parents confirm their agreement with these financial conditions and with the School Handbook, available at www.jfk.ch.
- By signing this document, parents agree to abide by all policies contained herein. They undertake to maintain this contractual agreement with JFK until their child leaves the school.
- The contractual agreement between the parents, the child and the school is governed by Swiss law. The term 'parents' in this document refers to the child's legal representative(s).
- Any dispute between the school, students and parents will be brought before the tribunal of Bern, Switzerland.
